- 1) \$250 deposit to save the date is to be delivered before acceptance of this contract.
- 2) Payment is to be made in full prior to the start of the ceremony.
- No editing will be done until payment/fees are paid in full.
- 3) Spruce Films/Don Swanson maintains ownership of the master video and reserves the right to use the video and/or reproductions in whole or part for promotional purposes.
- 4) It is your responsibility to provide chronologically labeled pictures for your picture montage (if applicable) either on a CD or some other commonly used digital medium. No editing will begin until pictures are received.
- 5) One meeting is included at no charge prior to the wedding regardless of which package is chosen, however, it is the client's responsibility to request said meeting.
- 6) It is appreciated if a meal is provided at the reception, however, if one is not other arrangements will be made which may result in missing reception events at no penalty to Spruce Films/Don Swanson.
- 7) The \$250 deposit to save the date is non-refundable if you, the client, cancel services for *any* reason.
- 8) Extreme care in filming and handling footage is taken, as is producing the final product, however, if the final product is not delivered in accordance to this contract, for any reason, Spruce Films/Don Swanson's liability is limited to refund of the deposit and any additional monies paid.
- 9) Prices for additional copies are subject to change over time and dependent upon condition of original master disc.
- 10) All checks are to be made payable to Don Swanson.
